# **CODE OF EHTICS FOR RESEARCH**

### **Objectives:**

The Code of Ethics for Research at the Model Institute of Engineering & Technology (MIET) is to set forth the institutional vision for quality research while adhering to the highest standards of ethics. The Code of Ethics for Research incorporate the basic principles which shall serve as the foundations for the attainment of the research objectives of the institution. There are three objectives for articulating a separate code of ethics for research at MIET:

- 1. To conduct research which is relevant, encompasses original ideas, innovation and creativity while building on and giving credit to research conducted by external experts in the field.
- 2. To ensure that research is conducted in a manner that serves the interests of individuals, groups, the region and the society as a whole.
- 3. To conduct research activities in an ethically sound manner, considering issues such as the management of risk, protection of confidentiality and based on informed consent.

# Honesty and Integrity

Be honest in reporting scientific data, results, methods, procedures and publication status. Avoid fabrication, copying, falsification and misrepresentation of data. Maintain accuracy and abide by the rules and regulations of the institution and globally accepted research norms. Be consistent in complying with publishing agreements and honor all licensing terms and conditions.

# **Ethics**

• Do not be negligent in correcting errors. Compare the work with that of the peers with careful and critical analysis. Maintain perfect record of the data collected, research design with proper documentation.

• Share data, results, ideas, tools and resources with the fellow researchers. Accept criticism and novel ideas in professionalism and be competent in improving expertise.
